An EC meeting has been called for the members of the Executive Committee 2024-26 of Bangladesh Garment Buying House Association (BGBA) on 23/06/2024 at 12:00 pm at BGBA Office, Banani, Dhaka.

## Minutes

As no objection or recommendation received on the resolution of 5<sup>th</sup> EC Meeting (EC/05/2024/2024-26/May-02) EC Committee approved and confirmed the resolution accordingly. Honorable President Md. Mofazzal Hossen Pabel & Treasurer Md. Fazlul Haque participated virtually through video conference.

Below mentioned points/agendas has been discussed on meeting:

# 1) BGBA Fund Management & Payroll Management

• BGBA Office will be relocated from Banani to Uttara (New Premises) by end of July 2024 or first week of August, 2024. Total cost will be approximately BDT- 70,00,000 (70 Lac) to BDT- 100,00,000/- (01 core) for the Relocation, Interior design, interior work, implementation, furniture, painting, chair, coffee lounge, conference room, delegation room. For AC in 04 floors, reception and coffee lounge we need around 50 tons to 60 tons which will cost us around BDT-50,00,000/- (50 Lac). So total budget will be around BDT-1,50,00,000/- (01 core 50 Lac). All these expenses will be collected by sponsors / donation from BGBA office bearers, respected any BGBA members, BGBA business partners & well-wishers so that this would not impact BGBA's actual fund. To start working we will be using BGBA fund at this moment and we will be working to collect all donations / sponsorship money to replenish BGBA fund.

- Taxpayer's Identification Number will be created for BGBA and a part of BGBA's fund will be deposited with the best FDR available. So far FDR interest offer received from Ceylon Bank (11.5%), Meghna Bank (13%), Lanka Bangla Bank (10.5%-11%) & Dhaka Bank (11%), NRB Global (12%), NRBC (11.5%). We will decide in next EC meeting to proceed with any bank.

## 2) Interior Decoration & Setup Cost for BGBA New Office

Total cost will be approximately BDT-70,00,000 (70 Lac) to BDT-100,00,000/- (01 core) for the Relocation, Interior design, interior work, implementation, furniture, painting, chair, coffee lounge, conference room, delegation room. For AC in 04 floors, reception and coffee lounge we need around 50 tons to 60 tons which will cost us around BDT-50,00,000/- (50 Lac). So total budget will be around BDT-1,50,00,000/- (01 core 50 Lac). These all amounts will be collected by sponsors / donation from BGBA office bearers, respected any BGBA members (voluntary), BGBA business.

From now onwards, for New Membership & Membership Renewal, an individual has to submit Tax Return Certificate, last 03 years AIT information if business is 03 years or more older, 03 years shipment / sales value if business is 03 year or more older, No. of Employee information to support BGBA data bank which would help to negotiate with all RGM stakeholders, government to get more facilities for BGBA.

# 5) Finalize 3rd Party Auditor for quarterly audit & report

- T. Hussain & Co. Chartered Accountants has been selected for followings, below decisions has been taken:
- a. Audit will be done for the Accounts of the year 2021,2022 & 2023.
- b. Audit of the Accounts of the Financial Year 1st July 2023 to 30th June 2024 will also be done.
- c. From now onwards Audit will be done of the Financial Year basis. So that BGBA can submit Income Tax Return and gets other benefits.
- d. BGBA financial data /accounts will be audited quarterly basis for management checking and the same report will be shared with general BGBA members as part of transparency.
